

Going forward

Proposed changes to Abbott offer

- Target price: ≤\$20 per test all-inclusive, DAP (including instrument placement, reagents and consumables, service and maintenance, connectivity, accessories, inventory) for all tests procured, across ALL instruments in country (previously purchased and newly placed).
- Focus on existing install base. Most countries, at least in a first phase, will try to utilize and transition the
 current footprint, therefore an all-inclusive price offer that does not include instrument placement, hence
 <\$20, would be useful to facilitate the decision to adopt and support VL on mPIMA, and increase utilization
 of current devices.
- **No hidden costs**. Example, costs associated with device removal and shipment to the capital, or logistic costs of field staff repairing the instruments.
- Placements based on minimum expected volume, without commitment. Placements selected
 collaboratively with the MoH based on shared site assessments and expected volume. Periodically, Abbott
 and the MoH review the testing volume at the sites where mPIMA has been placed and discuss the actions
 to be taken to increase the demand whenever this might fall below minimum yearly volume agreed (actions
 include instrument reallocation or other demand generation activities)
- One year contract. The contract will be for one year and will automatically extend to the next year unless is cancelled at the end of year 1
- Replacement of tests due to IQC failures* (optional)
